Ordinance No. 610.030

Licensees shall pay a fee based upon the gross amount of sales by such license, and it shall be computed on a graduated scale each quarter subject to merchant's year to date annual sales. **Every person considering a business licensed under this ordinance shall by the last business day of January, April, July, and October of each year and upon discontinuance of business in the City of Moline Acres, present to the City Clerk at the City Hall, a verified statement showing the total sales made during the preceding quarter year of fraction thereof and shall pay to the City the amount of license fee hereon before provided, for sales made during the previous calendar quarter year or fraction thereof.** The City Code Enforcer and any other officer designated by he or she shall have the power and authority to enter any store, building, or any other place in which such business may be conducted, at any time during business hours, for ascertaining the amount of sales made, and shall at all times have access to the books of such business.

The scale is computed based on Y-T-D annual sales as follows:

.550% sales between \$1 - \$4,000,000.00	.575% sales between \$4,000,001.00 - \$10,000,000.00
.600% sales between \$10,000,001.00 - \$20,000,000.00	.625% sales between \$20,000,001.00 - \$30,000,000.00
.650% sales between \$30,000,001.00 - \$35,000,000.00	.700% sales greater than \$35,000,001.00

Note: A true copy of your Missouri Sales Tax Report for the applicable year must accompany this report. If you do not have a Missouri Sales Tax Report, this statement must be notarized.
